# Greater Austin Emmaus 4<sup>th</sup> Day Group Board of Directors Meeting Manor UMC Thursday, March 5, 2015

The regular meeting of the GAE4DG Board was held on Thursday, March 5, 2015 commencing at 6:00pm at Manor UMC. The meeting was called to order by Mel Chambers and the opening prayer was given by Tom Rioux. Present were Mel Chambers, Lay Director; Chris McKemie, Assistant Lay Director; Anne Rioux, Immediate Past Lay Director; Tom Rioux, Rio Texas Board Rep.; Debby Duplantis, Treasurer; Carl Fisher, Board Member for Walk Support; LeeLeen Sundbeck, Board Member for Gathering Support; Jim Burgess, Board Member for Member Support; Kellye Noret, *WalkTalk* Editor; Debby Krueger, Lay Director for Women's Walk #1789.

**Minutes:** The Board approved the February minutes by email.

**Treasurer's Report:** Debby Duplantis presented the treasurer report. Tom Rioux made a motion to approve the report, Carl Fisher seconded and the treasurer's report was approved.

**Rio Texas Board Representative's Report:** Tom Rioux presented the Team Selection for Men's Walk #1803. Mel Chambers made a motion for the BOD to approve the team selection, Tom Rioux seconded the motion and the BOD approved the team selection. Tom reported a Lay Director is still needed for the Women's Walk in November, 2015.

Tom Rioux made a motion that the changes to the GAE4DG Bylaws be read, Carl Fisher seconded the motion and the BOD passed the first reading of the Bylaw changes. The changes are: references to SWTC are to be changed to read RTECC (Rio Texas Emmaus & Chrysalis Community); responsibility for the Treasurer: Shall promptly comply with any request to review the income, expenses, and finances of the GAE4DG with the person or persons making the request being responsible for any direct expenses such as making copies, minor grammatical changes; a Walk Board Representative shall have been a Walk Lay Director on a GAE4DG sponsored walk.

**Gathering Support:** LeeLeen Sundbeck reported that Wesley UMC will host the May 7, 2015 Gathering. This will be a pot luck Gathering with worship and a short program presented. Flyers will be given out at the April Gathering to inform the community about this Gathering and an email blast will be sent. Emmaus Sunday will be held on March 22.

**Walk Support:** Carl Fisher reported all went well with agape and prayer vigils for the Men's Walk #1778. Welcome Back for Men's Walk #1778 was attended by 17 pilgrims and all on the Walk agreed it "was the best walk ever." Carl also reported the GAE4DG now has 3 people approved for childcare.

**Immediate Past Lay Director Report:** Anne Rioux has not yet heard any updates from Gary Johnson concerning the GAE4DG application to become a 501(c)3 organization. Mel Chambers advised that he met a gentleman on Walk #1778 who has expertise in such matters and agreed to make contact with Gary Johnson to see what is needed to bring the matter to a conclusion.

**Assistant Lay Director:** Chris McKemie reported two people are in prayerful consideration for serving on the BOD in the positions of ALD and Member Support, and Mel Chambers has accepted the position for Board Rep. Rob Turk has accepted the position of Music Coordinator and will be starting in June.

Spiritual Director: Rev. Cheryl Broome was not present and no report was given.

Chrysalis Report: Tim Deschner was not present and no report was given.

**Walk #1778 Update:** David Graham was unable to attend tonight's BOD meeting. Close out report for Men's Walk #1778 will be given at the April BOD meeting.

Walk #1789 Update: Debby Krueger, LD for Women's Walk #1778, reported all the Walk's teams are complete. There are 11 confirmed pilgrims and 3 more applications are being processed.

**Old Business:** BOD voted to approve 1/3 scholarships for the first 21 Pilgrims for each Walk for the entire year of 2015.

Mel Chambers motioned the meeting be adjourned, Debby Dupantis seconded. The meeting was adjourned at 7:00pm by Mel who gave the closing prayer.

# Christ Descended to Lift Us Up – Easter Vigil

The sentence of Christ's descent into hell gained usage in the middle of the fourth century, as an ancient church historian from that day tells us. Today, by way of ecumenical church councils that met to combat the heresies of their day, we confess these words in the Apostles' Creed.

We confess these words, for they come to us from Scripture. The Apostle Peter tells us that Christ was "put to death in the flesh but made alive by the Spirit, by whom also He went and preached to the spirits in prison, who formerly were disobedient." (I Peter 3:18-19)

Christ descended into hell to display His defeat over sin, death, and the devil. He descended to proclaim His victory! Thanks be to God that He has given us the victory through Jesus Christ, our risen Lord and Savior! Christ suffered hell on the cross so that we would not have to go to the cross and die ourselves. Christ descended into hell that He might lift you and draw you to Himself. And now has Christ washed you in Holy Baptism, even as He has cleansed His bride, the Church. He has emptied the tomb so that you would be filled on His gifts. Thanks be to God!

Christ is risen! Christ is risen indeed! Alleluia!
